





APPLYING FOR CHANGE OF LANDUSE (CLU)











Note:

- Before applying for CLU, please check whether the land lies within FMDA jurisdiction. If the village falls under Municipal Corporation Faridabad, please apply on their respective website/office. Link to notification No. T&CP/FMDA/7/12/2020-2TCP dated 03 September 2020: Refer to page 7-10 of the document for list of villages under FMDA.
- 2) If the site is part of any unauthorized colony then applicant is required to get the violation under section 7(i) of Urban Area Act, 1975, compounded by the Director, Town and Country Planning Haryana, Chandigarh. CLU application is liable to be rejected without compounding order.
- 3) If the CLU applied is not implemented within 2 years from the date of CLU grant, then an extension may be awarded by FMDA for 3/4/5 + 1 year. First year extension will be decided by CEO, FMDA and subsequently if the project is not completed CLU extension for 1 more year may be granted by the Government of Haryana. This will be subject to genuineness and reasons for not completing the project within the stipulated time.
